#### MEETING REGARDING IMPLEMENTATION OF RECOMMENDATIONS OF THE STUDY "ISSUES OF GIRLS' EDUCATION IN SINDH"

Honourable Ombudsman Sindh, chaired the meeting regarding implementation status of recommendations of the study "Issues of Girls' Education in Sindh" with Secretary SE&LD and M.D., SEF. The Regional Directors of the Ombudsman Offices also gave their feedback on the issues of Girls School. The Secretary SE&LD agreed to resolve the issues specially of shortage of teachers, attendance of teachers through strict monitoring and activation of SMCs to be headed by female parents.



#### ESTABLISHMENT OF LADIES ROOM / DAY CARE CENTER AT SECRETARIAT PROVINCIAL OMBUDSMAN SINDH

The Ladies Room / Day Care Centre was inaugurated by Ms. Rebecca Poole, Assistant Principal Ombudsman, Western Australia.

The Center was established on initiative of Ombudsman Sindh, Mr. Ajaz Ali Khan, to provide women friendly facilities i.e restroom, prayer room and daycare to the female employees of the Secretariat, such facilities are uncomman in government departments.

#### HIGHLIGHTS OF REDRESSAL OF PUBLIC GRIEVANCES

#### <u>COMPLAINANT GOT FINANCIAL ASSISTANCE</u> <u>OF RS.600,000/-</u>

Mr. Muhammad Uris Rustamani son of a Naib Qasid of Government Boys Higher Secondary School Daur who died in June, 2019 approached the Provincial Ombudsman Sindh in June, 2022 and received financial assistance of Rs.600,000/- on intervention of Provincial Ombudsman Sindh.

#### MOTHER RECEIVED FAMILY PENSION OF HER DECEASED SON

Mst. Kaz Banu wd/o Naseer Muhammad Rind filed complaint stating that her son Ali Asghar was constable in Sindh Reserve Police (SRP), Hyderabad and died during service on 04.02.2009 and thereafter his widow was receiving family pension but in the year 2015 she contracted second marriage, therefore, she being mother approached the SRP to transfer family pension to her but received no response, hance approached this Institution for intervention.

After pursuation, the Superintendent of Police, SRP Hyderabad, reported that pension of deceased Constable Ali Asghar has been transferred in the name of complainant who experessed her thankfulness.

#### RS. 90,000/- PAID TO WIDOW TOWARDS AID OUT OF BENEVOLENT FUND

Mst. Dur Bibi filed a complaint alleging that authorities concered failed to release arrears of aid out of Benevolent Fund since March, 2019 despite her constant persuasion. Aggrieved by that, she approached the Ombudsman for intervention.

The Accounts Officer, Benevolent Fund Office, Karachi reported that the claim of Rs. 90,000/- of complainant had been approved and paid to her, which was also comfirmed by the lady.

#### RUPEES 3.2 MILLION PAID TO RETIRED HIGH SCHOOL TEACHER

Mr. Niaz Hussain filed complaint stating that he retired from service on 31.05.2021 and approached the District Accounts Office, Naushahro Feroze for payment of service dues but to no avail and requested to intervene.

After intervention of Ombudsman Sindh, he received all the service dues including commutation Rs.2,192,223/-, Leave encashment Rs. 723,240/- and arrears of pension Rs. 364,012/- (total Rs. 3,279,475/-).

#### WATER SUPPLY RESTORED IN MUSLIM LEAGUE QUARTERS, NAZIMABAD

Mr. Badar Rizvi R/o. Muslim League Quarters, Nazimabad, Karachi filed complaint regarding non-supply of water in his vicinity since long.

The Executive Engineer (Water), Liaquatabad Town reported that the water supply of potable water in the area in question has been resolved and assured lying of six inches diameter water line to improve supply of water in the area.

The complainant confirmed the position and expressed his thanks for resolving his long pending problem.

#### Rs.6.168 MILLION PAID BY DR. RUTH K.M. PFAU / CIVIL HOSPITAL

Syed Raees Haider, General Manager Operations, M/s Omer Razzak Enterprises Ltd. filed a complaint stating that his company had provided service of security guards to Dr. Ruth K.M Pfau (Civil Hospital) from September, 2020 to July, 2021 satisfactorily but payment for the period from March, 2021 to June, 2021 amounting to 6.168 Million was not made. Having failed to receive response from the authorities concerned, requested the Ombudsman Sindh to intervene.

The Agency after getting permission from Finance Department to clear the said liabilities during current financial year 2022-23 presented two cheques which were delivered to the complainant who confirmed redressal of his grievance and thanked to this institution.

#### ARREARS OF FAMILY PENSION PAID TO WIDOW

Mst. Nasreen Widow of Ghulam Hyder Kaheri complained that her husband was a Teacher in School Education Department, Badin and expired in the year 2021 but despite lapse of more than one year payment of service dues amounting to Rs. 190,314/- has not released by the District Accounts Officer, Badin.

District Accounts Officer, Badin has reported that due to financial constraints the payment of arrears could not be paid. However, after pursuation the District Account Officer Badin paid the amount of Rs. 190,314/- to the complainant who expressed her thankfulness for releasing of payment.

#### COMMUTED PORTION OF PENSION RESTORED

Mr. Munawar Hussain widower of Najma Ahmed, retired School Teacher, r/o. Chakwal, approached the Provincial Ombudsman Sindh by alleging delay in restoration of commuted portion of pension of his late wife by office of A.G. Sindh.

As a consequence of Ombudsman's timely intervention the scrutiny process was expedited by the office of AG Sindh and after completion of the required formalities, the restoration of the commuted portion of pension was done and its arrears amounting to Rs. 626,808/- were paid to him.

The complainant confirmed the position and appreciated the role of the Ombudsman for taking prompt action and providing speedy justice to him.

#### ALLEGED DEMAND OF BRIBE FOR RELEASING SALARIES TO THE NEWLY APPOINTED JST(S)

Mr. Waliullah Laghari in his complaint on 16.02.2023 against Sindh Education & Literacy Department alleged about demand of bribe for finalization of process of salaries of newly appointed JSTs, hence solicited intervention.

The Taluka Education Officer (TEO) Male, Elementary and Secondary and Higher Secondary, District Ghotki, reported that the matter has been resolved as F.O.Forms of all JSTs along with complainant's file were sent to the District Accounts Office, Ghotki @ Mirpur Mathelo for release of their salaries.The complainant confirmed the position and thanked for prompt redressal of the grievance.

#### <u>COMPLAINANT APPOINTED AS LADY</u> <u>CONSTABLE</u>

Mrs. Kainat in her complaint alleged that she had qualified the written / physical tests and also cleared the interview and medical tests for her recruitment as Lady Police Constable but in final merit her name was inadvertently mentioned against District Hyderabad instead of Tando Allahyar which was not being rectified despite her repeated approaches resultantly her appointment order has not been issued. She, therefore, solicited intervention.

DIG Police Hyderabad Range reported the after completion of formalities, offer letter for the post of Lady constable (BPS-05) in Sindh Police, District Tando Allahyar, has been issued in favour of the complainant, who in her written statement confirmed that she has joined the duty and extended thanks to Ombudsman Sindh for his prompt and immediate action to resolve the grievance.

#### ESTABLISHMENT OF HELP DESKS FOR DIFFERENTLY ABLED PERSONS

The Hon'ble Ombudsman has pleased to establish Help Desks for the Persons with Disabilities at Head quarter as well as 19 Regional Offices to ensure protection of rights of Persons with Disabilities, which is the basic purpose of establishment of institution of Ombudsman.

Complaints Section of Head quarter is designated as Help Desk for the Persons with Disabilities and Mr. Asadullah, Complaint Section is nominated as Focal Person / Coordinator.

All Regional Directors are also directed to nominate the Assistant Registrar(s) or any senior official as Focal Person/Coordinator for the Help Desk for the Personswith Disabilities in their respective Regional Offices.



On directives of Mr. Ajaz Ali Khan, Honourable Ombudsman Sindh, passed in the complaint filed by Mr. Muhammad Aslam, construction of building of Government Dispensary, village Haji Mir Khan Nuqrach, has been completed.
