HIGHLIGHTS OF REDRESSAL OF PUBLIC GRIEVANCES

RS. 1,163,510/- TOWARD SERVICE DUES RECEIVED BY MR. GHULAM NABI MALLAH, MALERIA SUPERVISOR, HEALTH DEPARTMENT.

Mr. Ghulam Nabi Mallah, retired Malaria Supervisor approached this Secretariat in February 2022 stating that he retired from service on 22.07.2021 but still waiting for payment of service dues viz G.P. Fund, Gratuity & Leave Encashment etc. from District Accounts Officer Naushahro Feroze.

On constant persuasion by this Secretariat, he received his dues amounting to Rs. 1,163,510/-.

WIDOW RECEIVED GROUP INSURANCE OF
RS. 2,100,000/- ON INTERVENTION OF
PROVINCIAL OMBUDSMAN SINDH.

Mst. Janul Wd/o Ali Muhammad Soomro filed a complaint in August 2023 against District Education Office (E,S&HS) Jacobabad and Deputy Manager, State Life Insurance Corporation, Pakistan for their alleged delay in payment of dues towards group insurance in respect of her husband who expired on 27.04.2019.

Due to prompt action by Regional Director, Jacobabad, she received Rs. 2,100,000/- towards group insurance and while acknowledging the efforts made by Ombudsman Office expressed her thankfulness.

COMPLAINANT GOT POSSESSION OF PLOT ON INTERVENTION OF OMBUDSMAN SINDH.

On the complaint filed by Syed Baqar Raza regarding re-allotment of his plot No. 320, Block 30-D, Shah Latif Town, Honourable Ombudsman Sindh directed the Director General, MDA for cancellation of unlawful allotment of the plot to Mr. Muhammad Imran Khan, as well as subsequent execution of its lease and mutation / transfer order and to handover its peaceful vacant physical possession.

After protracted correspondence, the Agency in compliance of orders of Honorable Ombudsman Sindh cancelled the documents/ transactions made in favour of Mr. Muhammad Imran Khan and also handed over possession of the said plot to the complainant who confirmed redressal of his grievance due to persistent follow up by the office of Ombudsman Sindh.

ON INTERVENTION OF OMBUDSMAN SINDH SERVICE DUES OF RS. 1,003,748/- PAID TO THE PENSIONER.

Mr. Muhammad Khan filed a complaint against District Accounts Officer Sujawal regarding delay in payment of his service dues though his pension papers forwarded to the Agency on 23-02-2022.

The case was admitted and the District Accounts Officer, Sujawal was advised to submit report. The District Accounts Officer, Sajawal after continuous persuasion reported that an amount of Rs. 1,003,748/- as pensionery dues have been paid to the complainant hence his grievance was redressed.

SON OF WIDOW GOT APPOINTMENT AGAINST DECEASED QUOTA.

Mst. Salma wd/o Abdul Rasheed filed a complaint on 07.04.2023 wherein she alleged delay in appointment of her son against deceased quota due to objection raised by District Recruitment Committee (DRC) despite approval of his case by the Chief Secretary Sindh.

On the intervention of Provincial Ombudsman Sindh, case of her son was reconsidered by District Recruitment Committee and has been appointed as Naib Qasid against deceased quota in School Education & Literacy Department.

CULVERT FOR CROSSING OF IRRIGATION WATER BETWEEN KANDIARI TO TANDO MITHA KHAN ROAD CONSTRUCTED TO FACILITATE THE AGRICULTURIST

Mr. Fazal Karim filed a complaint stating that his agriculturel land situated in Deh Sethar, Taluka & District Sanghar is being irrigated through Water Course No. 5/L, Samar-Jo-Branch, passing through link road between Kandiari to Tando Mitha Khan. He alleged that due to non-construction of bridge (culvert) by the Agency, he was not getting irrigation water for his land, hence solicited intervention.

The complaint was admitted and referred to Superintending Engineer Provincial Highways Circle, Mirpurkhas for appropriate action to redress the grievance who got constructed the desired culverts to facilitate the complainant in cultivations of his land.
